<u>16-0599</u> Recommendations from the City Attorney on proposed parking hanger ordinance.

City Attorney suggested the hangers only be used for the side street business's. Suggesting charging 15.00 per month or having them complete a lease agreement. Using color coded hangers to identify per business and time frame of parking. Business's would have to go through an application process where business's based on needs can get a hanger. City Attorney will draft a system to be introduced at the July council meeting and it will come back to the July Public Safety meeting for approval.
