Greg Minikel from DPI stated this was a request from 2011 and at that time the request was denied. The crosswalk lines are painted but there are no signs. A motion was made to approve the request to install the pedestrian signs.

Citizen Mr. Ed VanderBloomen presented his concerns about the heavy pedestrian traffic at the Southeast corner of South 23rd and Dewey Street when school is in session. His major concern is the speeding traffic in this area and the issues of school children being able to cross safely. He would like to see pedestrian signs on that corner. Alderperson Soeldner stated he understands the situation is dangerous but he is also concerned about the number of requests the committee has received for these lights to be placed around the city. Alderperson Kummer feels that the speed limit and the speeding is a problem and stated maybe we need to do something about that as a city. Such as taking a look at the staffing of the Police Department and maybe adding 1 or 2 more officers. Alderperson Sladky stated he agrees with Alderperson Kummer that the speeding is an issue within the city. Alderperson Czekala thought maybe we could put an officer at that location to monitor the traffic situation. Chief Nick Reimer stated we would not be able to put someone there everyday due to manpower shortage. We have a number of officers out on FMLA and one out with an injury and we are down to minimum staffing. A study was done in 2009 with the number of pedestrians in that area. Some days were higher than others. Mr. VanderBloomen feels the issue warrants the need for pedestrian signs. The Police Chief stated that the cost for the signs runs right around \$10,000-\$12,000 dollars. Alderperson Able stated he would love to see more enforcement in that area but that would mean an increase in the budget for more officers. No motion or vote was taken as it was decided to have DPI do another pedestrian study and this issue will be revisited at the next meeting.

The owner of Maritime Cab Mr. Dan Matthews was present to discuss his concerns regarding the regulations for Uber drivers versus City Taxi drivers. Every year they have to apply and get approval to have a Taxi Cab license. Mr. Matthews believes that Uber drivers should have the same standards that the City Taxi cab drivers do. Liz Majerus the Staff Attorney stated that Uber drivers have to be licensed by the state. They also need to be insured by the state. The city does not have authority to regulate Uber because they are state mandated. Alderperson Jim Brey was present and he suggested that Mr. Matthews should speak with Representative Paul Tittl to find out the rationale behind it. Alderperson Kummer felt there was really nothing we could do as a committee and we should not get involved with the state. Alderperson Able suggested to Mr. Matthews that he keep the committee up to date with more information as he received it. Staff Attorney Liz Majerus suggested Mr. Matthews start with other Municipalities and the Chamber of Commerce to get more information. A motion was made to place this item on file.

Part of the issue is that there is a boulevard at that intersection. There is a 2 way stop at that location but it also is all down hill which is 255 feet from the top of the hill to the bottom. This would make it difficult for traffic to come to a stop especially in slippery weather. Greg Minikel from DPI state that stop signs should be used to assign right away not to control speed. A motion was made to place on file.

Discussion was had on this amended ordinance regulating the Public Nuisance Properties. This ordinance is enacted to encourage property owners to recognize their responsibility to ensure that activities occurring on their premises conform to the law and do not unduly burden the City's Police and Division of Life Safety Services and to provide a mechanism for the City to take action against property owners who fail to ensure their premises do not require a disproportionate devotion of City resources. A City Nuisance Committee has been created to include a representative from the Police Department, Division of Life Safety and Neighborhood Services, Community Development, Public Infrastructure and the City Attorney's Office. Alderperson Kummer questioned if the committee would ask an Alderperson to also get involved. Alderperson Kummer made a motion to have an Alderperson on the committee. There was no second motion to this. The decision was made by the Public Safety Committee that the Public Nuisance Committee would meet every month and a motion was made by Alderperson Kummer that they report to the Public Safety Committee on a monthly basis.
