COMMERCIAL GARBAGE HAULER’S LICENSE APPLICATION CHECKLIST

A complete Commercial Garbage Hauler’s License Application shall include a letter of credit in the amount of \$10,000 on a form prepared by the City Attorney from a financial institution licensed to do business in the State of Wisconsin, and payment of a license fee of \$30 per vehicle used in the business of hauling.

Upon application approval by City staff and Common Council, the Applicant shall supply to the City Clerk’s Office, within ten business days, proof of insurance with the following minimum limits:

- General Liability: \$1,000,000 per occurrence
- Auto Liability: \$300,000 combined single limit bodily injury and property damage
- Worker’s Compensation at the statutorily required limits
- Environmental / Pollution Coverage: \$1,000,000 per occurrence or an agreement indemnifying and holding the City as harmless from any claims resulting from the licensed activities associated with garbage hauling.*

If **not** providing Environmental / Pollution Insurance Coverage, please see and sign Indemnification below.

Additional Insured Endorsement or equivalent, naming “The City of Manitowoc”

Failure to timely submit the necessary insurance information may result in non-issuance of license.

By signing below, Applicant certifies that the information contained in this Application and supporting documentation is true and accurate as of the time of signing. Applicant agrees to comply with all applicable federal, state, and local regulations and understands that the granting of this license does not presume to give authority to violate or cancel any applicable provisions of federal, state, or local law.
